If your late return forces another Member to arrange alternate transportation, the GRCS will also charge you for the cost of the alternate transportation.</i></p> <p><i>If you fail to return the vehicle two hours past your reserved return time, without calling to extend your trip period or to inform the answering service, the service will call your phone number(s). If you cannot be contacted, the vehicle will be reported to the police as missing.</i></p>	<p><i>However, if you call the reservation line <u>prior to the end of your current reservation</u> in order to extend it and <u>if</u> an extension is possible because no one has reserved the vehicle immediately after your current reservation, you can extend your current reservation and you will be charged at the applicable rates.</i></p> <p><i>If your late return forces another Member to arrange alternate transportation, the GRCS <u>will also charge you</u> for the cost of the alternate transportation. Thus, to avoid late fees you are strongly encouraged to allow for extra time when making your reservations.</i></p>
